TuffPlank's Limited Warranty provides protection on TuffPlank Luxury Vinyl and Floating Plank products from manufacturing defects solely to the original purchaser and is not transferable under any circumstances. TuffPlank will supply new products of the same or similar style, size, color, grade and gauge for repair or replacement of any manufacturing defects found in TuffPlank Luxury Vinyl and Floating Plank products. TuffPlank may, at its discretion, require inspection of any/all claims, and request photographs and/or samples prior to approving claims. All TuffPlank flooring is warranted against manufacturing defects, improper wear, fade or stain acceptance that would result in loss of original pattern and color, under normal use and maintenance, from the date of purchase through the specified times stated in this warranty. Products must be installed and maintained according to the TuffPlank Installation & Maintenance Instructions in order to be covered by this Limited Warranty.

**\* DEFINITIONS of covered items:**

- "Wear" is defined as affecting the wear layer such that the printed pattern is affected or altered.
- "Fade" is defined as the permanent discoloration of the flooring and pattern on the planks.
- "Stain" is defined as an alteration of the flooring due to normal household cleaning agents, chemicals or routine care & maintenance.

### Pre-Installation Limited Warranty:

TuffPlank provides a Pre-Installation Warranty for visual defects. ALL planks MUST be carefully inspected PRIOR to installation to verify that there are no visual defects. Should you find any defects, do NOT install those pieces and contact TuffPlank immediately for replacements. Once products are installed, this Pre-Installation Warranty ceases to be valid and the general TuffPlank Warranty takes effect. TuffPlank will not be responsible for any claim for product installed with visual defects.

### Wear Limited Warranty:

TuffPlank Luxury Vinyl and Floating Plank is protected with a wear layer. This wear layer is the most important part of your flooring. It protects the decorative layer from the affects of everyday use and keeps it looking new. TuffPlank's Wear Warranty covers the wear layer from "wear-through" for the amount of years indicated for the specific product.

"Wear-through" is defined as the complete loss of the wear layer such that the printed layer is changed or affected. The Wear Limited Warranty only applies to installations where TuffPlank recommended installation and maintenance procedures have been followed.

### TUFFPLANK Limited Warranty Exclusions:

- Improper Installation
  - Normal wear and tear
  - Reduced gloss
  - Product sold as Irregulars or "as is"
  - Improper or insufficient maintenance
  - Non functioning HVAC or missing thermostats
  - Improper temperature outside of recommended temperature range
- Damages from misuse including discoloration from use of improper floor mats or substances such as asphalt or other substances listed in the maintenance and product guides.
  - Consumers should be aware that colors may vary from samples and printed materials to actual production runs. This does not constitute a defect and is not covered under warranty. Explicit dye-lot requirements must be stated at the time of order.
  - Any installation that does not expressly follow installation instructions or is not first expressly approved by Tuffplank in writing prior to installation.
  - Damages resulting from abuse including, but not limited to burns, cuts, scratches and stains.
  - Damages or failure of floor to adhere to subfloor resulting from improper installation or moisture.

**NOTE** - Heavy-wheeled traffic may permanently indent your TuffPlank Luxury Vinyl Flooring and damage of this type is not covered under this Exclusive Limited Warranty.

**NOTE** - Commercial installations have express limitations on manufacturers defects, wear, fade & stain based upon the Wear Layer depth purchased. Please review the warranty guidelines for further information of covered areas.

**NOTE** - Avoid exposure to direct sunlight for prolonged periods. The use of drapes or blinds is recommend. Prolonged direct sunlight can result in discoloration, and change in dimensional stability causing expansion.
